The ARP ESSER funds under the ARP Act are provided to Local Educational Agencies (LEAs) to address the impact that the Novel Coronavirus Disease 2019 ("COVID-19") has had, and continues to have, on elementary and secondary schools in Florida. This includes helping school districts and other LEAs safely reopen schools, restore and maintain high-quality learning environments, measure and effectively address significant learning loss, and take other actions to mitigate the impact of COVID-19 on the students and families who depend on our K-12 schools through September 30<sup>th</sup>, 2024. Not less than 20 percent of such funds will be reserved to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that

such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on the student subgroups described in section 1111(b)(2)(B)(xi) of the Elementary and Secondary Education Act of 1965 (20 U.S.C. 6311(b)(2)(B) (xi)), students experiencing homelessness, and children and youth in foster care.

DESKTOP AND NOTEBOOK COMPUTERS AND SERVICES FROM
HEWLETT-PACKARD COMPANY

#### **Description**

Hewlett-Packard Company has provided Sarasota County Schools with a comprehensive product and service program utilizing The State of Florida Contract 43211500-WSCA-15-ACS (NASPO Value Point) for Computer Equipment, Peripherals and Services. This provides ongoing asset management, deployment logistics, warranty and repair support as well as service management. This agreement provides the district with a turnkey leasing solution for computer replenishment that proves the best of product and services. It is based on a 4-year lease for equipment utilization, management, warranty, repair and support for six elementary schools: (Alta Vista; Emma E Booker; Fruitville; Garden; Gocio; Glenallen); two middle schools: (Booker Middle; McIntosh Middle); and two high schools: (Booker High; Riverview High). Key benefits of this agreement are: This effort is year 1 of a 4-year plan for computer refresh and deployment district-wide, and, prepares Sarasota schools to meet the standards for digital testing requirements. Computers removed from the schools involved in this phase and less than 4 years of age will be deployed to other district schools.
