QUALIFICATIONS:

- Possess an Associate Degree from an accredited educational institution or, equivalent transportation experience as determined by the Director of Transportation.
- Minimum of <u>Three to</u> Five (<u>3</u>-5) years of [successful] mechanical experience <u>or fleet management</u> experience.
- ASE Master Certification for Heavy Truck, and School Bus or <u>equivalent experience as determined by</u> <u>the Director of Transportation.</u>
- <u>At least two (2) years of administrative or leadership experience.</u>
- [Ability to] Possess a valid State Florida Commercial Driver's License (CDL) with Passenger, Air Brakes and "S" Endorsements within the first 6 months. [Required]

KNOWLEDGE, SKILLS AND ABILITIES:

- Knowledge of federal, state and local standards of transportation services.
- Possess managerial skills.
- Ability to plan, analyze, organize and prioritize activities.
- Ability to communicate effectively, both orally and in writing.
- Possess excellent computer knowledge and skills.
- Knowledge of vehicle service and maintenance techniques and procedures.
- Knowledge of safety standards for vehicles.
- Ability to use technology to enhance management of the department.

JOD OBJECTIVES:

To provide overall coordination, supervision, and direction for the day to day operation of Fleet Maintenance which assures the safe and efficient operation of all District vehicles.

PERFORMANCE RESPONSIBILITIES:

- Supervise, discipline and evaluate garage staff in accordance with established rules and
- procedures.
- Ensure that the bus fleet is maintained to the highest safety standards and in compliance with federal, state and local rules and regulations.
- Ensure that other School Board vehicles are properly maintained for a safe and efficient operation.
- Set up and monitor preventative maintenance scheduling.
- Ensure that the fleet maintenance facilities and fleet are in compliance with the regulatory requirements of OSHA and the EPA.

FLEET MAINTENANCE SUPERVISOR (Continued)

- Prepare bid specifications and oversee the purchasing of fuel, oil, repair parts and tools and equipment needed to maintain the bus fleet and other vehicles owned by the District.
- Ensure that mechanics are trained and up-to-date on new technologies and regulations.
- Purchase and maintain fleet maintenance software and electronic diagnostic software and equipment.
- Interact with parents, outside agencies, businesses and community to enhance the understanding of the District's initiatives and priorities as they relate to transportation services.
- Respond to inquiries and concerns in a timely manner.
- Keep the Superintendent informed, through proper channels, of potential problems or unusual events.
- Work closely with District and school staffs on all matters related to transportation services.
- Disseminate information and current research to appropriate personnel.
- Keep well informed about current trends and best practices in areas of responsibility.
- Maintain expertise in assigned areas to fulfill project goals and objectives.
- Facilitate the development, implementation and evaluation of staff development activities in assigned areas.
- Promote and support the professional growth of self and others.
- Develop annual goals and objectives consistent with and in support of District goals and priorities.
- Maintain a network of peer contacts through professional organizations; such as, the Florida Association of Pupil Transportation.
- Attend training sessions, conferences and workshops to keep abreast of current practices, programs and legal issues related to assignments.
- Assist with the development of the department budget and monitor its implementation.
- Supervise assigned personnel, conduct annual performance appraisals and make recommendations for appropriate employment action.
- Prepare or oversee the preparation of all required reports and maintain appropriate records.
- Serve on District, state or community councils or committees as assigned or appropriate.
- Represent, consistently, the District in a positive and professional manner.
- Provide leadership and direction for the assigned areas of responsibility.
- Provide leadership and guidance in the development of annual goals and objectives for assigned department or program.
- Utilize appropriate strategies and problem-solving tools to make decisions concerning planning, utilization of funds, delivering services and evaluation of services provided.
- Assist in implementing the District's goals and strategic commitments.
- Exercise proactive leadership in promoting the vision and mission of the District.
- Provide oversight and direction for cooperative planning with other agencies.
- Set high standards and expectations for self and others.
- Demonstrate initiative in identifying potential problems or opportunities for improvement and take appropriate action.
- Use appropriate styles and methods to motivate, gain commitment and facilitate task accomplishment.
- Facilitate problem solving by individuals or groups.
- Perform other incidental tasks consistent with the goals and objectives of this position.
 - Every Sarasota County Schools employee has emergency response responsibilities, though not every position will require routine assignments during an emergency event.
